### **Show Hours for both days:**

*Check-in will be from 7:30 a.m. to 8:30 a.m. and the advertised show hours are 9:00 a.m. to 5:00 p.m.*

### **Benching Requests:**

*Only ONE benching request per exhibitor will be honored. Handicapped benching requests will be accommodated, whenever possible, at no extra charge to the exhibitor.*

### **Vetting:**

*The show will be non-vetted. All entries should be inoculated by a licensed veterinarian against feline enteritis, feline rhinotracheitis, calici virus, rabies. Entries should be tested for FeLV and be free of parasites. All claws of entries must be clipped prior to benching.*

### **Transportation:**

*Exhibitors will be responsible for their own means of transportation.*

### **Scoring:**

*All championship, premiership, and registered kittens will be scored for CFA National and Regional awards.*

**Miscellaneous:** *Show management will take reasonable care of cats and carriers, but will not be responsible for loss or damage. The show hall is a NON-SMOKING facility and is heated and air conditioned. Benching cage size is 22x22x22.*
